The type of personal information we collect

We currently collect and process the following information:

- Personal identifiers, contacts, and characteristics (for example, name and contact details)

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- To contact you in the future regarding our organisations deliverable service
- To ask for your feedback on our services
- To ask for your participation in promotion or endorsement of the service
- To use to promote the services and volunteer activities of SAW UK

We may also receive personal information indirectly, from the following sources in the following scenarios:

- Persons close to you as family, friends or otherwise connected
- Via a professional third party ligned with Save A Warrior UK in a professional capacity

We use the information that you have given us in order to communicate our organisational activities directly to you via email, sms, phone or social media direct messaging. We may share this information with other professional organisations with or without your permission.

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing this information are:

- (a) Your consent. You are able to remove your consent at any time. You can do this by contacting us via email at info@saveawarrioruk.org
- (b) We have a contractual obligation.
- (c) We have a legal obligation.

- (d) We have a vital interest.
- (e) We need it to perform a public task.
- (f) We have a legitimate interest.

How we store your personal information

Your information is securely stored. We keep identifying data for 12 months. We will then dispose of your information by manually deleting from our servers.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

How to complain

You can also complain to the ICO if you are unhappy with how we have used your data.
